FOR THE FISCAL YEAR JULY 1, 2019- JUNE 30, 2020

BE IT RESOLVED by the Bienville Parish School Board in general session convened that:

SECTION 1: The attached detailed estimate of revenues for the fiscal year beginning July 1, 2019 and ending June 30, 2020, be and the same is hereby adopted to secure as an Operating Budget of Revenues for the Bienville Parish School Board during the same period.

SECTION 2: The attached estimates of expenditures by departments for the fiscal year beginning July 1, 2019, and ending June 30, 2020, be and the same are hereby adopted to secure as a Budget of Expenditures for the Bienville Parish School Board.

SECTION 3: The adoption of Budget of Expenditures as reflected in the attached line item budget containing account object of expenditures classifications shall be declared to be the appropriation of the amounts set there as established in each budget classification by object or expenditure.

SECTION 4: Amounts are available for expenditures only to the extent included within the 2019-2020 budget.
