

The Bienville Parish School Board met in regular session Thursday, June 4, 2020, at the Bienville Parish School Board Annex, 1956 First Street, Arcadia, Louisiana, with the following members present: Ms. Sharolyn Boston, Mr. Mickey Hampton, Ms. Freddie Blow, Ms. Bonita Reliford, Ms. Martha Grigg, Dr. Larry Knotts, and Mr. Donald Calloway. All members were present.

The meeting was called to order by the President, Mr. Mickey Hampton, and the invocation was given by Dr. Larry Knotts, followed by the Pledge of Allegiance led by Superintendent William Wysinger.

Motion by Ms. Martha Grigg, seconded by Ms. Bonita Reliford, passed, approving the agenda posted May 28, 2020 for the June 4, 2020 regular meeting of the Bienville Parish School Board.

Motion by Dr. Larry Knotts, seconded by Mr. Donald Calloway, passed, approving the minutes of the regular meeting on May 21, 2020 as distributed.

Motion by Ms. Bonita Reliford, seconded by Ms. Sharolyn Boston, passed, deferring milk bids for the upcoming school year until the next school board meeting July 2, 2020.

Motion by Mr. Donald Calloway, seconded by Ms. Sharolyn Boston, passed, placing proposed policy revisions on public display from June 5, 2020 through July 1, 2020. The policy revisions are:

Upon the recommendation of the Superintendent, motion by Ms. Martha Grigg, seconded by Ms. Bonita Reliford, passed, to accept the proposal from Risk Services for student activity insurance coverage for a period of one year (July 1, 2020 – June 30, 2021) in the amount of \$21,228.59.

As advertised, quote/proposals was received May 28, 2020 for General Liability, Educator's Legal Liability, Cyber Suite, Fleet, and Property Insurance for the period of July 1, 2020 through June 30, 2021. Upon the recommendation of the Superintendent, motion by Ms. Sharolyn Boston, seconded by Ms. Freddie Blow, passed, accepting the proposal submitted by PCAL for General Liability, Educator's Legal Liability, Cyber, and Fleet Insurance in the amount of \$149,958.00 for the period July 1, 2020 through June 30, 2021. The proposal for Property Insurance was in the amount of \$206,080.70 for the period July 1, 2020 through June 30, 2021 (Total coverage breakdown with the following companies: Illinois Union \$76,065.60; Arch Specialty \$31,979.35; Evanston Insurance Company \$26,737.75; and Homeland Insurance Company \$71,298.00).

Upon the recommendation of the Superintendent, motion by Ms. Bonita Reliford, seconded by Mr. Donald Calloway, passed, approving revisions to the 2019-2020 Bienville Parish School Board budget as presented by Mr. Jarvis Osborne, Business Manager.

Motion by Ms. Bonita Reliford, seconded by Ms. Martha Grigg, passed, authorizing the Superintendent to place the proposed 2020-2021 Bienville Parish School Board budget on public display from June 5, 2020 to July 1, 2020.

Motion by Dr. Larry Knotts, seconded by Ms. Freddie Blow, passed, authorizing the Superintendent to conduct a public hearing at 1956 First Street, Arcadia La. on July 2, 2020, at 5:30 p.m., for presentation of the 2020-2021 Bienville Parish School Board budget.

There being no further business to come before the Board, motion by Ms. Bonita Reliford, seconded by Ms. Sharolyn Boston, passed, adjourning the meeting.
