

The Bienville Parish School Board met in regular session Thursday, September 3, 2020 at the Bienville Parish School Board Annex, 1956 First Street, Arcadia, Louisiana, with the following members present: Ms. Sharolyn Boston, Mr. Mickey Hampton, Ms. Freddie Blow, Ms. Bonita Reliford, Dr. Larry Knotts, and Mr. Donald Calloway. Absent was Ms. Martha Grigg.

The meeting was called to order by the President, Mr. Mickey Hampton, and the invocation was given by Ms. Bonita Reliford, followed by the Pledge of Allegiance led by Superintendent William Wysinger.

BE IT FURTHER RESOLVED that the proper administrative officials of the Parish of Bienville, State of Louisiana, be and they are hereby empowered, authorized, and directed to spread said taxes, as hereinabove set forth, upon the assessment roll of said Parish for the year 2020, and to make the collection of the taxes imposed for and on behalf of the taxing authority, according to law, and that the taxes herein levied shall become a permanent lien and privilege on all property subject to taxation as herein set forth, and collection thereof shall be enforceable in the manner provided by law.
