

The Bienville Parish School Board met in regular session Thursday, November 5, 2020 at the Bienville Parish School Board Annex, 1956 First Street, Arcadia, Louisiana, with the following members present: Ms. Sharolyn Boston, Mr. Mickey Hampton, Ms. Freddie Blow, Ms. Martha Grigg, Dr. Larry Knotts, and Mr. Donald Calloway. Ms. Bonita Reliford was absent.

The meeting was called to order by the President, Mr. Mickey Hampton, and the invocation was given by Dr. Larry Knotts, followed by the Pledge of Allegiance led by Superintendent William Wysinger.

Motion by Ms. Freddie Blow, seconded by Ms. Martha Grigg, passed, approving the agenda posted October 30, 2020 for the November 5, 2020 regular meeting of the Bienville Parish School Board.
